Notes on funding:

Individual events can be funded with up to 185 euros. If an association/initiative would like to receive funding for two or more events, the total funding per association/initiative is up to 400 euros.

Events are only funded if:

- they clearly match at least one of the current main topics of the Intercultural Days (ICD)
- **they are free and open to the public**
- they comply with the participation conditions for the ICD
- they are published in the program booklet of the ICD

The funding is limited. Therefore, mainly associations/initiatives are supported that do not receive funding. As a rule, the following associations and institutions do not receive an event funding:

- Associations that receive year-round state financial support (institutional support or project support);
- Institutions of the city administration and state institutions.

Participants can be all Dresdeners and institutions that want to contribute to an open and tolerant treatment of all people living here. A democratic, pluralistic attitude is required.

In concrete terms, this means that people and organizations who are committed to civic engagement, democratic behavior and diversity in society can participate.

Excluded are persons and organizations that are active against the free democratic basic order as well as persons or organizations from extremist structures within the meaning of Section 4 of the Federal Constitutional Protection Act and Section 3 of the Saxon Constitutional Protection Act and those who are demonstrably close to them.

The Ausländerrat Dresden e. V. concludes a service contract with the associations/initiatives that receive funding. After the event, the funded associations/initiatives must send in a short final report (with photos). The form of the final report can be downloaded at www.auslaenderrat.de/veranstalter. Invoices do not have to be submitted.
